## Town of Fort Qu'Appelle OCP & Zoning Bylaw - P. KORPAN/ V. HAMILTON

### Proposed Residential Subdivision SUBD-000863-2022- G. LEGACE/J. PELLETIER

23-07 THAT the Calling Lakes District Planning Commission recommends approval of the proposed residential subdivision as there are no nearby land uses that may be incompatible with the intended use of the proposed site; no facilities could be affected and it is consistent with the District Plan. The Commission also recommends that the applicant ensures municipal reserve dedication requirements have been met. Ensure that sanitary waste disposal system must meet the Provincial Health Authority and municipality requirements. Also, provides a buffer between agricultural and residential developments where described and allowed for in The Planning and Development Act, 2007. Furthermore, ensures that member municipalities discuss with developers the importance of contacting First Nation and Metis communities in the area to identify concerns and mitigation methods, should they be necessary.
